Precautions to minimise the risk of Coronavirus infection and transmission

A Covid risk assessment has been carried out as attached. Everyone attending plays a big part in helping to minimise the risk of cross-infection. All individuals are responsible for the following:

- 1. You must not attend classes if:
 - you have Covid symptoms (high temperature, new continuous cough, change to sense of smell or taste).
 - you have been notified by test and trace and required to self-isolate.
- 2. You must notify the tutor (jsrose@ntlworld.com or 07703 608068) and course administrator (patdavoll2@gmail.com) of any subsequent positive Covid test and to support notification of test and trace.
- 3. Access to the kitchens is limited to a maximum of 2 volunteers.
- 4. Only one person should be in the toilets at any time.
- 5. Please bring your own hand sanitiser and use it after each dance. (serTA will also supply hand sanitiser.)
- 6. Please bring your own refreshments and mugs. We hope to serve tea and coffee, but there will be no use of hall crockery.
- 7. Please maintain physical distancing when not dancing.

Other points to note

Mask wearing is no longer a requirement and is generally impractical during dancing. However you are welcome to wear a mask if you are more comfortable doing so.

We hope that you have all been vaccinated but we cannot require you to prove your vaccination status nor even ask if you have been vaccinated.

We are not making any stipulation about self-testing for Covid in advance of attending.

Pat will be maintaining a register of all attendees at each class. Please ensure that she has your contact telephone number and/or email address.
